The Office of Inspector General (OIG) conducted an audit of Amtrak's (the company) website security program. Our audit objective was to assess whether current controls provide reasonable assurance that the company's publicly accessible websites are secure.

BACKGROUND

The company uses numerous information technology (IT) applications accessible to the public via the Internet. Given the company's reliance on publicly accessible websites, we compared its practices for IT website security to leading practices from the private and public sectors, including those of the National Institute of Standards and Technology.

SUMMARY OF RESULTS

We identified areas where the company's website security practices could be improved, and recommended specific security improvements to management.

MANAGEMENT COMMENTS AND OIG ANALYSIS

In commenting on a draft of this report, the company's Executive Vice President for Planning, Technology, and Public Affairs agreed with our recommendations and described planned corrective actions that, if fully implemented, will address our recommendations.

SCOPE AND METHODOLOGY

We conducted our audit work from November 2015 through July 2017 in Washington D.C. We conducted this performance audit in accordance with generally accepted government auditing standards. Those standards require that we plan and perform the audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions based on our audit objectives. We believe that the evidence obtained provides a reasonable basis for our findings and conclusions based on our audit objectives. Given the sensitive nature of the report's information, the results have been summarized in this public version of the report.
